ANTLION PIT COMPETITION PARTICIPANT ACKNOWLEDGMENT AND AGREEMENT

The **Entomological Society of America** (ESA) has organized an Antlion Pit Competition (APC) with awards to be made during ESA's Annual Meeting, November 5-8, 2023, in National Harbor, MD. The competition is open to all registered attendees of the Annual Meeting. APC participants (either individuals or teams) will propose projects for which they would like to receive funding to advance their work in the field of entomology. ESA will award one first place winner with a prize of \$5,000. ESA will select judges for the competition. The judges' decisions are final; and judges are under no obligation to award all – or any – of the prize money.

Each Antlion Pit Competition team must submit a written proposal (the "Proposal") containing a description of the project and how the funds would be used if awarded. Proposals must be received by ESA no later than Monday, August 21, 2023. Participants should be prepared to make final pitches in support of their Proposals during open sessions of the Annual Meeting and to answer judges' questions. The open sessions may be broadcast live or recorded for later broadcast via radio, television, podcast or social media. Although Proposals will be distributed only to judges and ESA staff, participants should have no expectation that their Proposals will remain confidential. As a condition to participating in the Antlion Pit Competition, each individual participant and each member of a participating team must sign this Participant Acknowledgment and Agreement.
